Established in 1915, Mountain Lake is an exclusive and historic seasonal club and real estate development corporation with 106 shareholding members. It was originally designed by Frederick Law Olmstead, Jr. and is listed on the National Register of historic places. Club amenities include: an 18-hole golf course designed by Seth Raynor; five har- tru tennis courts, fitness center, orange groves, swimming pool, two croquet courts, trap and skeet shooting. Colony House, designed in Mediterranean Revival architecture by Frederick Law Olmstead, Jr., is 56,000 square feet. It hosts formal dining in season and features 36 overnight rooms and suites serving members and guests on the Modified American Plan. A separate casual poolside restaurant offers indoor and outdoor dining, and poolside refreshment. The 18-hole golf course is ranked as one of Golf Magazine's Top 100 Classic Golf Courses and is considered one of the best courses in the state of Florida.

Open year-round, the Club is staffed by the General Manager and COO, administrative staff and golf course and community maintenance; there are 135 employees in season and 60 year-round. The golf course and tennis courts are open seven days a week; the food and beverage operation is open seven days a week for breakfast, lunch and dinner from November to April. Gross revenues of the Club are \$12.3 million with food and beverage accounting for \$1.1 million.

The General Manager and COO is responsible for managing all operations of Mountain Lake consistent with the direction and policies established by the Board of Directors as well as by the By-laws and Rules and Regulations of the Club. The General Manager and COO will lead the team of department heads that includes the Executive Chef, Head Golf Professional, Director of Croquet and Tennis, Golf Course Superintendent and Membership/Office Manager, and orange growers. The General Manager and COO will act as the community manager ensuring services to the homeowners within the Park and oversee the real estate office.

The successful candidate will have proven experience leading and managing all facets of a seasonal, very highend private club, the community, real estate marketing and sales, and agricultural and land use interests. With full P&L responsibility, candidates must possess strong communication, operational and excellent financial skills and demonstrate fiscal management through resourceful use of assets and deployment of labor.
