



## **The Westmoor Club – Nantucket, Massachusetts**

### **Chief Financial Officer (CFO)**

The Westmoor Club is a premier private club located on 15 acres in the Cliff area of Nantucket, just a mile from the center of the Town of Nantucket. Established in 2005, this modern and sophisticated privately owned club bustles with social and physical activity and honors Nantucket's nautical traditions with fishing, sailing, and yachting. At the center of the property is the restored 1917 summer home built for Alice Vanderbilt that serves as the main clubhouse. Amenities include: three grass tennis courts, 10 Har-Tru courts, two paddle tennis courts, two squash courts, two swimming pools, three jacuzzis, a 20,000 square foot state-of-the-art Spa and Fitness Center, and two yachts –Westmoor I, a 30 foot captained sport fishing boat and the magnificent and classic 77 foot, wooden yacht, Belle. Club programming includes junior and adult programs for all sports and an award winning children's summer camp. The Club is currently full at 480 members.

Club operations are seasonal with full services, seven days a week, from June 15 to September 15 including à la carte service for breakfast, lunch and dinner; banquets operate from mid-May to December 15. The 15,000 square foot clubhouse features seven guest rooms and two dining rooms which can accommodate up to 200 guests indoors; the pool café and additional outdoor dining amenities are available. Annual gross revenues exceed \$7.5 million. Food and beverage sales are more than \$1 million of which 40% are derived from private events.

The CFO is responsible for directing the financial operations and functions of the Club and assisting the General Manager and Finance Committee on all strategic matters relating to budget development, management, analytics/metrics, forecasting needs and internal controls. The CFO- also develops policies to control and coordinate accounting, auditing, budgets, taxes and related activities and records and develops, establishes and administers procedures and systems pertaining to all financial matters. The CFO rigorously oversees the A/P and A/R function to ensure timely and accurate input and processing of payables and receivables.

The CFO reports to the General Manager and the Finance Committee. He/she will attend the Finance Committee meetings as requested and is responsible for preparing the necessary accounting reports for distribution to the management staff, Finance Committee, and Owners.

This position requires a team player with excellent leadership, management, and verbal and written communication skills as well as excellent analytic skills with the ability to exercise sound judgment. Being viewed as a leader by the team is critical.

Candidates must have graduated from a four-year college or university with a degree in accounting, finance or a related field and have five to seven years professional accounting experience with half of those years serving in a Controller capacity - ideally. Preference will be given to candidates with an MBA in Finance and CPA or CHAE certification. Non-profit and hospitality experience is attractive as is professional experience working with IT, spa operations and HR.

Candidates must demonstrate a desire, interest and commitment to live on Nantucket and embrace barrier island living. Candidates must also be eager and willing to work in a seasonal club environment with availability to work on the weekends as needed.
