



## **The Country Club of Virginia – Richmond, Virginia Food and Beverage Director**

The Country Club of Virginia (“CCV”) is a world-renowned Country Club located in Richmond, Virginia. The Club features two campuses: the traditional full-service country club offered at Westhampton, with an historic Clubhouse built in 1910, and the golf club offered at James River. CCV offers 54 holes of golf with 18 holes at Westhampton and 36 located at James River. The Westhampton Clubhouse (70,000 sq. ft.) amenities are of a traditional full-service family Club with a four-acre resort-style pool complex featuring adult, family, and competition pools and a diving well. Paddle tennis, event lawns, youth activity areas, squash, indoor and outdoor tennis courts, fitness, and a spa round out the Westhampton campus. The James River Clubhouse (36,000 sq. ft.) will host the Dominion Energy Charity Classic for the second year this fall as part of the PGA TOUR Champions Charles Schwab Cup. James River is located seven miles from Westhampton and offers dining and event space with locker rooms to complement its two championship golf courses. Additionally, the Club features a landing on the James River with storage for boats, paddle boards, and kayaks. Two exciting new outdoor event venues are located on the James River property – the Red Brick Barn and the Farmhouse.

Richmond, Virginia’s historic state capital, is a culturally diverse and vibrant city. With a metropolitan population of 1,250,000, it retains the charm of picturesque neighborhoods and enjoys a four-season climate. It is being recognized as a great food city, boasting some of the East coast’s most renowned chefs. Richmond is also known as a great place to live, with mountains, beaches, and the nation’s capital each within a two-hour drive. Ranked #28 in *U.S. News & World Report’s* 2016 “Best Places to Live in the USA,” Richmond is the only city in America with whitewater rapids running through its downtown district. The metro area features more than two dozen craft beer breweries as well as countless wineries. Among the local attractions are numerous museums, festivals every month of the year, and Civil War historical sites. The city offers many year-round activities drawing from its role as the state capital and the number of excellent colleges and universities that surround it. Richmond is an excellent urban environment featuring the best of a big city without the hustle and bustle found elsewhere.

The Country Club of Virginia is open daily year-round and provides three notable restaurant facilities – Ollie’s and The Grill at Westhampton and the James River Dining Room – along with several snack bars and a large full-service Poolside Cafe. In addition, the Club will open a new fast-casual dining concept as part of its \$19.6 million expansion of its Fitness and Racquet Sports facility in the summer of 2018. The Westhampton Clubhouse is one of Richmond’s most highly regarded event venues, with its two large ballrooms hosting many events that serve as the centerpiece to the social fabric of the Club’s 7,800 members. CCV’s banquet revenues exceed \$3 million, including 40 weddings a year. Holiday numbers in excess of 1,200 are not uncommon as both campus facilities are open and often serve to capacity.

Reporting to the General Manager, the Food and Beverage Director is an integral part of CCV’s executive management team and directly oversees: Director of Special Events, James River Clubhouse Manager, Ollie’s Manager, Executive Chef, Grill Manager, and Banquet Manager. The Food & Beverage department includes 250 staff and 15 managers. Key responsibilities will include recruiting and developing a strong team, managing budgets, interacting with committees, and maintaining a high level of visibility.

The successful candidate should have a warm and gracious personality and be a detailed operator who will exceed the Club’s high standards to enhance CCV’s national reputation as the best Club in the State of Virginia. The Food and Beverage Director is expected to be engaged with the management team and to be recognized as the front-facing leader by staff and members alike. A strong and personable leader, he/she will create a sound annual business plan aligned with CCV’s long-term vision for its food and beverage operations, inspire an environment of creativity among a talented and enthusiastic team, and direct them to execute at the highest levels. The Director will apply critical thinking in the planning and management of resources across both campuses and provide a compelling vision for future operations. The candidate needs to demonstrate financial accomplishment and an ability to continue to grow the business in collaboration with executive management’s direction.
